Instruction and Certification Test
Administration***

Do you wish to ensure that you and your facilities are in compliance with the recent New Jersey Food Code (Chapter 24) regulation that each institutional food service has a full time “Person in Charge” (PIC) with a current “Serve Safe” certificate? This new rule stipulates that you must have at least one certified staffer on duty during the entire time period your kitchen is open for production and service.

Join us this winter for an intensive one day review of ServSafe instruction, followed by the official certification test.

Successful completion of the exam satisfies the requirement that one PIC is certified. Seminar is geared to individuals for both initial and re-certifications, however, review of instructional material/course book is strongly recommended prior to the day of this review.
